

WHAT GIVES THIS HONOURABLE DIPLOMATIC STATUS LEGAL STANDING AND LEGITIMACY?

My Authority as follows,

Some years ago I was a member of the *International Parliament* and during this time I started a "think tank" group comprising of "Rightist" members of the *Club of 300* and various other committees and institutions. This included day to day public members as well.

I invited like-minded individuals who are members of *The Club of Rome* or *Club of 300*. I called this think tank group *Cabinet 2.0*.

We had an incredible group of people who could discuss and put forward ideas for solving issues on a localized "in community", as well as a broader world view basis.

I was asked by several influential members to give this group a Latin name and thus *Senatus Consultum Electus, Cabinet 2.0*. was chosen.

We consult with the Senates and the Governments of the world as well as elect people to extremely important positions in the world.

This became one of the largest and most influential think tanks with some of the most powerful people in its membership. This includes the *Council of Foreign Relations; Trilateral Commission; Bilderburg; Guilderburg; Jason Society* and many others including most governmental prime ministers; ministers of defence; and presidents.

Unfortunately too many others became members by existing members inviting new members, and infiltrated the Cabinet who were on the left and far left. This did not sit well with me at all. In short the original group morphed into something that it was never meant to be. I would like to add here that not everyone in the Club of 300 are in favour of the NWO, nor do they have left leanings. My own standpoint and philosophy sits on the right, not the far right, as a result of this infiltration of "globalists", I withdrew from something I had in fact birthed as it became distasteful to me.

My understanding of freedom of speech and substantiated debate, is to have all opinions left, centre or right, as non-democratic and not a one-sided discussion.

I believe in Law and Order, no matter which country, as this is necessary to live peacefully and in a way we all strive for. Unfortunately we sit with the problem that Law and Order has not seen the light of day for the last decade and a half, and specifically the last 5 years where it has gone haywire. Thus being the agenda of the "Elitists".

What many people do not realize is that by creating this chaos, division and hatred, and by reacting in violent ways, they are playing along with and into the hands of the NWO

proponents, with the emphasis being on the word *Order*. These three words have an emphasis on order and this is an order that you are not going to like. This is putting it mildly. It is the leftist, satanic, paedophilic, cabal driven order that is going to take away every single human right that you currently have. You will become nothing more than a dispensable slave, owning nothing. This is of course if you survive lining up for the suicide 'shot'.

Once I started the *New World Alliances*, I was asked how I intended to move ahead with it. I replied that I intend moving ahead with this with a similar committee as I had with *Senatus Consultum Electus*, calling this *Cabinet 3.0*, comprising of top minds in a think tank. Inviting only those who are on the same "right" frequency with a good balance of individuals who really believe in Human Rights across the board, their freedom and in the retaining of inalienable rights that we are born with.

As a member of the *International Parliament*, I knew I could invite some colleagues, not necessarily friends, but good minds to join me and add them into the *New World Alliances* think tank.

I have received a great deal of opposition from the *New World Order* as well as a lot of opposition from the previous *Senatus Consultum* leftist members. This is understandable because the leftists that were added were not done with my consent and one cannot jump from left to right. Daily death threats and threats from certain governments and institutions are becoming boring and laughable, with threats of financial exclusion and other necessary services have become the norm. This has brought about ever changing geo locations and has forced me to move out of my home at the coast in order not to have my family or life threatened.

As a member of the *International Parliament*, it gave me access to the *European Union*, the *European Commission*, the *European Parliament*, and the *United Nations Security Council*.

As a result of me heading up the Southern Command za as the South African leader, under the African Directorate, which is International Risk Management within the Global War Advisory Council (a.k.a. GWAC), I have a privileged degree of influence that I utilize as and when I need to in order to achieve results.

I have therefore issued an Ordinance of which most of you are aware of and many consider to be an insignificant piece of paper typed up in a question of 2-3 days. This in fact took much longer with a small team of exceptionally capable minds assisting with the final wording and editing. This alone took in excess of a week.

These documents were sent through to the *United Nations Security Council* which oversee the *United Nations* and all its entities. It was also sent to the *World Health Organization* and every single global Government that exist.

Therefore, all top officials were in receipt of this Ordinance. It was not only received but also notarized by the WHO and UNSC. This means it has been accepted by them.

They do not have to like the contents, however, they have to answer and acknowledge receipt thereof.

The Second Letter (order) that accompanied this was an Order stating clearly that we oppose the NWO draconian levels of manipulation, coercion and control over the citizens of the world.

Therein stating the intent to protect society by issuing individuals with *Honourable Diplomatic Certification as Peace Ambassadors*.

In the law, under the legislation concerning Diplomats, there is a clause that states that no diplomat may be forced, coerced or be expected to participate in a medical, social or defence experiment or programme.

This is where we found a loophole to include humans, citizens or normal people like you and I, into this group and to include "us" into this Honourable Diplomatic Status.

This is why I sent the intent to protect society with this certification, not only in South Africa which is my main seat of operations, but Worldwide. I have the authority to do this.

The next document, the Order was to directly notify all Institutions, Governments and Relevant Bodies of the Certificates.

Furthermore, in this documentation it was clearly states that as the general public we do not consent to being part of this '*experiment*'.

The charges and laws have been laid out to them clearly in this document stating categorically that action will be taken against anyone violating these rights.

Thereafter, letters of Cease and Desist will be sent out within South Africa to guilty parties who violate the human rights causing shut downs of the country etc. As in the case of the rest of the world.
