Objective:

As a representative of the New World Alliances, Ambassador Lodevik Brooks is tasked with conducting a comprehensive evaluation of human rights conditions in England. This mission will involve direct observation, stakeholder engagement, and analysis of potential human rights violations. The findings will contribute to the New World Alliances' ongoing efforts to address violations of God-given, inalienable human rights and promote justice, equality, and sustainability.

Assignment Overview:

1. Primary Goals:
 - Evaluate the state of human rights in England with a focus on healthcare, education, and social services.
 - Identify any instances or patterns of human rights violations, including but not limited to accessibility, equality, and freedom.
 - Provide an unbiased and factual report on living conditions and institutional practices as they relate to human rights.
2. Key Areas of Focus:
 - Healthcare Sector: Visit hospitals and medical facilities to evaluate accessibility, quality of care, patient rights, and treatment equity.

- Education Sector: Engage with schools and educational institutions to assess access to education, treatment of students, and inclusivity.
 - Community Engagement: Speak with a diverse cross-section of individuals, including local residents, community leaders, and institutional representatives, to gather insights on human rights concerns and societal well-being.
3. Media Monitoring: Compare firsthand observations with mainstream media reports to discern the accuracy of claims regarding human rights violations in the UK.

Diplomatic Mission Instructions:

1. Preparation and Documentation:
 - Familiarize yourself with UK human rights frameworks, including legislation, healthcare policies, and educational mandates.
 - Carry valid diplomatic credentials issued by the New World Alliances to facilitate access to necessary institutions and discussions.
2. Conduct During Assignment:
 - Represent the New World Alliances with the highest level of integrity, professionalism, and cultural sensitivity.
 - Ensure all interactions are recorded and documented, maintaining confidentiality where appropriate.
 - Request permission for interviews and visits when entering private or sensitive spaces, ensuring compliance with local regulations.
3. Reporting:
 - Submit a comprehensive report to the Global Office of Public and Cultural Affairs upon mission completion. This report should include:
 - Observations and evaluations.
 - Identified strengths and weaknesses in the human rights landscape.
 - Recommendations for further action or collaboration.

Support and Facilitation:

Ambassador Lodevik Brooks is to be afforded the respect, courtesy, and assistance befitting his role as a Global Ambassador Diaspora. Local institutions, community representatives, and residents are encouraged to:

- Facilitate access to relevant sites, including hospitals, schools, and community hubs.
- Provide honest and transparent feedback regarding human rights conditions.
- Ensure a safe and welcoming environment for diplomatic discussions.

INTRODUCTION TO NEW WORLD ALLIANCES

New World Alliances (NWA) is a globally recognised organisation dedicated to the protection, preservation and promotion of human rights, justice and dignity for all. New World Alliances operates under the principles enshrined in International humanitarian law and is registered with key global human rights bodies, including the United Nations (UN) and various International human rights commissions.

Our Commitment to Human Rights:

- **United Nations Registration:** New World Alliances is officially registered with the United Nations. Currently the New World Alliances has 15 executive committee members that all have fully-fledged United Nations entity numbers. The committee's mission is aligned with the UN's Universal Declaration of Human Rights and other key International treaties. This affiliation empowers New World Alliances Executive Committee members, especially appointed New World Alliances Envoys, VIP Global Ambassador Diaspora (GAD) and Global Ambassador Diaspora and its Honorary Diplomatic Peace Ambassadors Corp to monitor, report and act on any and all human rights violations worldwide.
- **Affiliations with Human Rights Bodies:** In addition to our UN registration, New World Alliances is affiliated and recognised by multiple human rights organisations across various regions, including the European Court of Human Rights, the Inter-American Commission on Human Rights and the African Commission on Human and Peoples' Rights. These partnerships and collaborations strengthen our ability to advocate for victims of genuine human rights abuses and hold violators accountable.

WHAT CONSTITUTES A BREACH OF HUMAN RIGHTS?

According to the New World Alliances Ordinance 2: ([PPCC//IRM/8266-ADIR06/5.RM28-G.AmdD#NWA0001](#)) and the standards set by the UN and other international bodies, a breach of human rights occurs when any individual, group, or institution engages in actions that violate the fundamental freedoms and rights of another person. These rights include, but are not limited to:

1. **Right to Life and Security:** Any action that threatens the life, safety, or well-being of an Individual.
2. **Right to Freedom from Discrimination:** Any act of bias or prejudice against an individual based on race, gender, nationality, religion, or any other status.
3. **Right to Fair Treatment:** Unlawful detention, forced medical procedures, and any other actions that deny an individual due process or equal protection under the law.
4. **Right to Privacy:** Any invasion of personal privacy without consent, including unlawful surveillance, searches, or seizures.
5. **Right to Free Speech:** Any attempt to suppress, censor, or penalise an individual for expressing their thoughts, opinions, or beliefs
